Growthpoint Properties Limited (**Growthpoint**, or the **Issuer**) intends from time to time to issue notes (the **Notes**) under the ZAR30,000,000,000 Domestic Medium Term Note Programme (the **Programme**) on the basis set out in the Programme Memorandum dated 25 October 2019, as amended and restated from time to time (the **Programme Memorandum**). The Notes may be issued on a continuing basis and be placed by one or more of the Dealers specified in the section headed “Summary of Programme” under the Programme Memorandum and any additional Dealer appointed under the Programme from time to time by the Issuer, which appointment may be for a specific issue or on an ongoing basis.

The specific aggregate nominal amount, the status, maturity, interest rate, or interest rate formula and dates of payment of interest, purchase price to be paid to the Issuer, any terms for redemption or other special terms, currency or currencies, form and denomination of Notes, information as to financial exchange listings and the names of the dealers, underwriters or agents in connection with the sale of Notes being offered at a particular time will be set forth or referred to in the terms and conditions contained in the Programme Memorandum (the **Terms and Conditions**), read together with the pricing supplement applicable to any Notes (the **Applicable Pricing Supplement** and this **Information Statement**).

In addition, factors which are material for the purpose of assessing the market risks associated with the Notes are also described below. The value of the Notes could decline due to any of these risks, and investors may lose some or all of their investment.

*The Issuer believes that the factors described below represent the principal risks inherent in investing in the Notes, but the inability of the Issuer to pay interest, principal or other amounts on or in connection with any Notes may occur for other reasons which may not be considered significant risks by the Issuer based on information available to it at the date of this Information Statement, being 31 May 2022 (**Information Statement Date**), or which it may not be able to anticipate at the Information Statement Date. Accordingly, the Issuer does not represent that the statements below regarding the risks of holding any Notes are exhaustive.*

Factors that may affect the Issuer’s ability to fulfil its obligations under Notes issued under the Programme

Risks Relating to the Notes

The Notes may not be a suitable investment for all investors

Each potential investor in any Notes must determine the suitability of that investment in light of its own circumstances. In particular, each potential investor should:

- have sufficient knowledge and experience to make a meaningful evaluation of the Notes, the merits and risks of investing in the Notes and the information contained or incorporated by reference in the Programme Memorandum or any applicable supplement;
- have access to, and knowledge of, appropriate analytical tools to evaluate, in the context of its particular financial situation, an investment in the Notes and the impact such an investment will have on its overall investment portfolio;
- have sufficient financial resources and liquidity to bear all of the risks of an investment in the Notes, including Notes with principal or interest payable in one or more currencies, or where the currency for principal or interest payments is different from the potential investor’s currency;
- understand thoroughly the terms of the Notes and be familiar with the behaviour of any relevant indices and financial markets; and
- be able to evaluate (either alone or with the help of a financial adviser) possible scenarios for economic, interest rate and other factors that may affect its investment and its ability to bear the applicable risks.

Some Notes are complex financial instruments. Sophisticated institutional investors generally do not purchase complex financial instruments as stand-alone investments. They purchase complex financial instruments as a way to reduce risk or enhance yield with an understood, measured and appropriate addition of risk to their overall portfolios. A potential investor should not invest in Notes which are complex financial instruments unless it has the expertise (either alone or with a financial adviser) to evaluate how the Notes will perform under changing conditions, the resulting effects on the value of the Notes and the impact this investment will have on the potential investor’s overall investment portfolio.

There may not be an active trading market for the Notes

Notes issued under the Programme will be new securities which may not be widely distributed and for which there is currently no active trading market (unless in the case of any particular Tranche, such Tranche is to be consolidated with and form a single series with a Tranche of Notes which is already issued). If the Notes are traded after their initial issuance, they may trade at a discount to their initial offering price, depending upon prevailing interest rates, the market for similar securities, general economic conditions and the financial condition of the Issuer. There is no assurance as to the development or liquidity of any trading market for any particular Tranche of Notes.

The Notes may be redeemed prior to maturity

Unless in the case of any particular Tranche of Notes the Applicable Pricing Supplement specifies otherwise, in the event that the Issuer would be obliged to increase the amounts payable in respect of any Notes due to any withholding or deduction for or on account of any present or future taxes, duties, assessments or governmental charges of whatever nature imposed, levied, collected, withheld or assessed by or on behalf of the government of South Africa or any political subdivision thereof or any authority therein or thereof having power to tax, the Issuer may redeem all outstanding Notes in accordance with the Conditions.

In addition, if in the case of any particular Tranche of Notes the Applicable Pricing Supplement specifies that the Notes are redeemable at the Issuer's option in certain other circumstances, the Issuer may choose to redeem the Notes at times when prevailing interest rates may be relatively low. In such circumstances an investor may not be able to reinvest the redemption proceeds in a comparable security at an effective interest rate as high as that of the relevant Notes.

Because uncertificated Notes are held in the CSD, investors will have to rely on their procedures for transfer, payment and communication with the Issuer

Notes issued under the Programme which are listed on the Interest Rate Market of the JSE or such other or additional Financial Exchange and/or held in the CSD may, subject to Applicable Laws and the Applicable Procedures, be issued in uncertificated form. Unlisted Notes may also be held in the CSD in uncertificated form. Notes held in the CSD will be issued, cleared and settled in accordance with the Applicable Procedures through the electronic settlement system of the CSD. Except in the limited circumstances described in the Terms and Conditions, investors will not be entitled to receive Individual Certificates. The CSD will maintain records of the Beneficial Interests in Notes and/or issued in uncertificated form, which are held in the CSD (whether such Notes are listed or unlisted). Investors will be able to trade their Beneficial Interests only through the CSD and in accordance with the Applicable Procedures.

Payments of principal and/or interest in respect of uncertificated Notes will be made to the CSD or the Participants and the Issuer will discharge its payment obligations under the Notes by making payments to or to the order of the CSD or the Participants for distribution to their account holders. A holder of a Beneficial Interest in uncertificated Notes, whether listed or unlisted, must rely on the procedures of the CSD to receive payments under the relevant Notes. Each investor shown in the records of the CSD or the Participants, as the case may be, shall look solely to the CSD or the Participant, as the case may be, for his share of each payment so made by the Issuer to the registered holder of such uncertificated Notes. The Issuer has no responsibility or liability for the records relating to, or payments made in respect of, such Beneficial Interests.

Holders of Beneficial Interests in uncertificated Notes will not have a direct right to vote in respect of the relevant Notes. Instead, such holders will be permitted to act only to the extent that they are enabled by the CSD to appoint appropriate proxies.

Recourse to the JSE Debt Guarantee Fund Trust

The holders of Notes that are not listed on the Interest Rate Market of the JSE will have no recourse against the JSE Debt Guarantee Fund Trust. Claims against the JSE Debt Guarantee Fund Trust may only be made in respect of the trading of Notes listed on the Interest Rate Market of the JSE and in accordance with the rules of the JSE Debt Guarantee Fund Trust. Unlisted notes are not regulated by the JSE.

Credit Rating

Tranches of Notes issued under the Programme, the Issuer, the Guarantors and/or the Programme, as the case may be, may be rated or unrated. A Rating is not a recommendation to buy, sell or hold securities and may be subject to suspension, reduction or withdrawal at any time by the assigning

Rating Agency. Any adverse change in an applicable credit rating could adversely affect the trading price for the Notes issued under the Programme.

Any amendment in the Rating of the Issuer and/or the Guarantors and/or the Programme and/or a Tranche of Notes, as the case may be, after the Information Statement Date, will be announced on SENS.

Risks related to the structure of the particular issue of Notes

A wide range of Notes may be issued under the Programme. A number of these Notes may have features which contain particular risks for potential investors. Set out below is a description of certain such features:

Notes subject to optional redemption by the Issuer

An optional redemption feature is likely to limit the market value of the Notes. During any period when the Issuer may elect to redeem the Notes, the market value of those Notes generally will not rise substantially above the price at which they can be redeemed. This also may be true prior to any redemption period. The Issuer may be expected to redeem Notes when its cost of borrowing is lower than the interest rate on the Notes. At those times, an investor generally would not be able to re-invest the redemption proceeds at an effective interest rate as high as the interest rate on the Notes being redeemed and may only be able to do so at a significantly lower rate. Potential investors should consider reinvestment risk in light of other investments available at that time.

Index-Linked and Dual Currency Notes

The Issuer may issue Notes the terms of which provide for interest or principal payable in respect of such Notes to be determined by reference to an index or formula, to changes in the prices of securities or commodities, to movements in currency exchange rates or other factors (each, a **Relevant Factor**) or with principal or interest payable in one or more currencies which may be different from the currency in which the Notes are denominated. Potential investors should be aware that:

- the market price of such Notes may be volatile;
- no interest may be payable on such Notes;
- payments of principal or interest on such Notes may occur at a different time or in a different currency than expected;
- the amount of principal payable at redemption may be less than the Nominal Amount of such Notes or even zero;
- a Relevant Factor may be subject to significant fluctuations that may not correlate with changes in interest rates, currencies or other indices;
- if a Relevant Factor is applied to Notes in conjunction with a multiplier greater than one or contains some other leverage factor, the effect of changes in the Relevant Factor on principal or interest payable is likely to be magnified; and
- the timing of changes in a Relevant Factor may affect the actual yield to investors, even if the average level is consistent with their expectations. In general, the earlier the change in the Relevant Factor, the greater the effect on yield.

Partly-paid Notes

The Issuer may issue Notes where the issue price is payable in more than one instalment. Failure to pay any subsequent instalment could result in an investor losing all of its investment.

Notes issued at a substantial discount or premium

The market values of securities issued at a substantial discount or premium from their principal amount tend to fluctuate more in relation to general changes in interest rates than do prices for conventional interest-bearing securities. Generally, the longer the remaining term of the securities, the greater the price volatility as compared to conventional interest-bearing securities with comparable maturities.

Variable Rate Notes with a multiplier or other leverage factor

Notes with variable interest rates can be volatile investments. If they are structured to include multipliers or other leverage factors, or caps or floors, or any combination of those features or other similar related

features, their market values may be even more volatile than those for securities that do not include those features.

Fixed/Floating Rate Notes

Fixed/Floating Rate Notes may bear interest at a rate that the Issuer may elect to convert from a fixed rate to a floating rate, or from a floating rate to a fixed rate. The Issuer's ability to convert the interest rate will affect the secondary market and the market value of such Notes since the Issuer may be expected to convert the rate when it is likely to produce a lower overall cost of borrowing. If the Issuer converts from a fixed rate to a floating rate, the spread on the Fixed/Floating Rate Notes may be less favourable than then prevailing spreads on comparable Floating Rate Notes tied to the same reference rate. In addition, the new floating rate may at any time be lower than the rates on other Notes. If the Issuer converts from a floating rate to a fixed rate, the fixed rate may be lower than then prevailing rates on its Notes.

Notes where denominations involve integral multiples: Individual Certificates

In relation to any issue of Notes which have denominations consisting of a minimum Specified Denomination plus one or more higher integral multiples of another smaller amount, it is possible that such Notes may be traded in amounts that are not integral multiples of such minimum Specified Denomination. In such a case a holder who, as a result of trading such amounts, holds an amount which is less than the minimum Specified Denomination in his account with the relevant clearing system at the relevant time may not receive an Individual Certificate in respect of such holding and would need to purchase a Nominal Amount of Notes such that its holding amounts to a minimum Specified Denomination.

If Individual Certificates are issued, holders should be aware that Individual Certificates which have a denomination that is not an integral multiple of the minimum Specified Denomination may be illiquid and difficult to trade.

Modification and waivers and substitution

The Conditions contain provisions for calling meetings of Noteholders to consider matters affecting their interests generally. These provisions permit defined majorities to bind all Noteholders including Noteholders who did not attend and vote at the relevant meeting and Noteholders who voted in a manner contrary to the majority.

Change of law

The Notes are governed by, and will be construed in accordance with, South African law in effect as at the Information Statement Date. No assurance can be given as to the impact of any possible judicial decision, change to South African law or administrative practice in South Africa after the Information Statement Date.

Legal investment considerations may restrict certain investments

The investment activities of certain investors are subject to legal investment laws and regulations, or review or regulation by certain authorities. Each potential investor should consult its legal advisers to determine whether and to what extent (1) Notes are legal investments for it, (2) Notes can be used as collateral for various types of borrowing and (3) other restrictions apply to its purchase or pledge of any Notes. Financial institutions should consult their legal advisers or the appropriate regulators to determine the appropriate treatment of Notes under any applicable risk-based capital or similar rules.

Material Risks relating to the Issuer's Business

The Issuer and the Guarantors believe that the following factors, as at the Information Statement Date, may affect their ability to fulfil their obligations under the Notes and the Guarantee. In addition, such factors could adversely affect the trading or the trading price of the Notes. All of these factors are contingencies which may or may not occur and the Issuer and the Guarantors are not in a position to express a view on the likelihood of any such contingency occurring.

In addition, factors which the Issuer and the Guarantors believe are material for the purpose of assessing the market risks associated with the Notes and the Guarantee are described below.

The Issuer and the Guarantors believe that the factors described below represent the principal risks

inherent in investing in the Notes, but the inability of the Issuer and the Guarantors to pay interest, principal or other amounts on or in connection with the Notes, and adverse impacts on the trading or the trading price of the Notes, may occur for other reasons which may not be considered significant risks by the Issuer and the Guarantors based on information currently available to them or which they may not currently be able to anticipate. Prospective investors should also read the detailed information set out elsewhere in the Programme Memorandum and reach their own views prior to making any investment decision.

The list of risks listed below is by no means exhaustive and other risks could be applicable.

1. Risks related to the economies in which the Group operates:

1.1 South Africa

- 1.1.1 The majority of the Group's portfolio is concentrated in South Africa, and its business and prospects will continue to be materially affected by economic and political conditions in South Africa;
- 1.1.2 The COVID-19 pandemic has had, and will likely continue to have, a significant effect upon the South African economy, which consequently may adversely affect the Group's business, financial condition and results of operations;
- 1.1.3 Any downgrade or change in outlook in the sovereign credit ratings of South Africa could have a material adverse impact on the Group's business;
- 1.1.4 The Group's financial condition is subject to the continued availability of funding from the South African bank markets and domestic capital markets;
- 1.1.5 The condition of South Africa's infrastructure, particularly with respect to transportation, electricity and sanitation, will continue to have a material impact on the performance of the Group's South African property portfolio;
- 1.1.6 Difficulty by the Group to comply with any current or future broad-based black economic empowerment (B-BBEE) and Property Sector Charter requirements could have a material adverse impact on the Group's operations in South Africa;
- 1.1.7 Any further significant decline in the V&A Waterfront's operating performance, including as a result of Covid-19, could have an adverse impact on the Group's business, financial condition and results of operations;
- 1.1.8 The Group's entry or expansion into new business areas, such as funds management and trading and development, will subject it to new economic and industry related risks;
- 1.1.9 South Africa's exchange control restrictions on foreign investment could hinder the Group's normal corporate functioning and its ability to make foreign investments; and
- 1.1.10 Uncertainty regarding land ownership rights could have a material adverse impact on the Group's business and financial conditions,

1.2 Australia and other jurisdictions

- 1.2.1 The Group is subject to changing political and economic conditions in Australia as a result of its shareholding in Growthpoint Properties Australia (**GOZ or Growthpoint Australia**);
- 1.2.2 As the Group holds a significant interest in Globalworth, the Group faces risk associated with economic, demographic and market developments in Romania, Poland and the Central and Eastern European (**CEE**) region;
- 1.2.3 As the Group holds a significant interest in Capital & Regional Plc (**C&R**), the Group faces risk associated with economic, demographic, market developments and Brexit in the United Kingdom; and
- 1.2.4 The prolonged effects of Covid-19 in the various jurisdictions could have a material adverse impact on the Group's business.

2. Risks related to the Group's business, strategy and industry:

- 2.1 The Group faces risks associated with the failure or insolvency of major tenants, particularly

- corporate tenants in South Africa;
- 2.2 The Group's entry or expansion into new business areas, such as funds management and trading and development, will subject it to new economic and industry related risks;
 - 2.3 The Group may pursue investment opportunities in countries in which it has no previous investment experience and may hold international investments in which it does not exercise majority investment control, which in each case may subject it to greater investment, economic, social and political risks;
 - 2.4 The Group may be unable to maintain its existing portfolio, expand, redevelop or refurbish its existing properties or develop new properties successfully;
 - 2.5 The Group may incur losses on external trading and development activities or on over-exposure to speculative developments;
 - 2.6 The Group operates in highly competitive markets and the supply of property developments in some locations, particularly in South Africa, continues to exceed demand;
 - 2.7 A reduction in the average duration of the Group's leases could result in increased re-letting costs and a higher risk of vacancies;
 - 2.8 The increasing administered costs and deteriorating infrastructure impact the cost of occupancy and the levels of rentals negatively;
 - 2.9 The growing densification and consolidation of retail, office and warehousing space in the Group's key markets could have a material adverse impact on the performance of its property portfolio;
 - 2.10 The Group may be unable to manage its growth effectively;
 - 2.11 War, natural disasters, terrorist attacks, pandemics or other catastrophic events could adversely affect the Group's business, financial conditions and results of operations;
 - 2.12 The Group's success is dependent on its ability to attract and retain key members of senior management, and the market for such talent remains extremely competitive;
 - 2.13 If the Group chooses to dispose of certain assets, it may be unable to do so on favourable terms or at all or may be subject to liability following such disposals;
 - 2.14 The due diligence that the Group has undertaken or intends to undertake in connection with any future acquisitions may not reveal all relevant facts in respect of such acquisitions and may not reveal material liabilities;
 - 2.15 The valuation of investments in real estate and related assets may require the Group to make assumptions, estimates and judgments regarding a number of factors. Property valuation is inherently subjective and uncertain and based on assumptions that may prove to be inaccurate or affected by factors outside of the Group's control;
 - 2.16 The increased work-from-home dynamic and work flexibility (which was accelerated by Covid-19) might impact the property space negatively;
 - 2.17 The Group's business model and competitive advantage could be challenged by the emergence of "disrupters" such as e-commerce providers;
 - 2.18 The Group's business model could be threatened by changes to working patterns and uncertainty regarding the future of offices; and
 - 2.19 Failure in the Group's information and technology systems, data privacy breaches or cybersecurity attacks could result in interruptions of the Group's business operations.
- 3. Risks related to the Group's financial condition:**
- 3.1 The Group may be unable to extend or refinance its existing debt obligations on favourable terms or at all;
 - 3.2 The Group might not be able to maintain financial covenants included in the various loan and bond documentation;
 - 3.3 The Group is subject to interest rate risk;

- 3.4 The Group could suffer losses as a result of fluctuations in foreign currency exchange rates; and
- 3.5 The derivative instruments employed by the Group to manage its interest rate and foreign currency exposure may not be effective and/or may result in losses for the Group.
- 4. **Legal and regulatory risks:**
 - 4.1 The Group faces certain costs related to compliance with environmental regulations as well as market-driven preferences for "green" buildings, and a failure to meet such requirements and/or market demands could have a negative impact on the Group's ability to attract and retain tenants;
 - 4.2 The Group may incur significant costs in complying with property laws and regulations;
 - 4.3 Title to the Group's properties may be uncertain and subject to challenge; and
 - 4.4 The Group has had, and may continue to have, difficulties in evicting tenants that are in default or difficulties in enforcing judgments against defaulting tenants.
- 5. **Risks related to the Group's REIT status:**
 - 5.1 Growthpoint might cease to be qualified as a South African REIT;
 - 5.2 Restrictions under the laws applicable to South African REITs may limit the Group's ability and flexibility to pursue growth through acquisitions; and
 - 5.3 A loss of REIT status as a result of certain property disposals or business combinations may have a negative impact on Growthpoint's profits and cash flows, which could in turn negatively affect its credit ratings and debt service ratios.

DESCRIPTION OF GROWTHPOINT PROPERTIES LIMITED

Capitalised terms used in this section headed "Description of Growthpoint Properties Limited" shall bear the same meanings as defined in the Terms and Conditions in the Programme Memorandum, except to the extent that they are separately defined in this section or this is clearly inappropriate from the context.

1. DESCRIPTION OF THE BUSINESS

1.1. Brief description

Growthpoint is a South African primary JSE listed Real Estate Investment Trust (**REIT**) with a quality portfolio of directly owned properties in South Africa. Growthpoint has a controlling interest in Growthpoint Australia, which owns properties in Australia. GOZ is listed on the Australian Securities Exchange (**ASX**). Growthpoint has a controlling interest in C&R, which owns properties in the United Kingdom. C&R is listed on the London Stock Exchange (**LSE**). Growthpoint has a 50% investment in the V&A Waterfront and an investment in London Stock Exchange (**AIM**)-listed Globalworth Real Estate Investments (**GWI** or **Globalworth**).

In line with Growthpoint's vision "to be a leading international property company providing space to thrive", Growthpoint's strategy incorporates the optimisation and streamlining of the South African portfolio, the introduction of new revenue streams via the Funds Management business (Growthpoint Investment Partners) and trading and development, and further international diversification.

Growthpoint's objective is to grow and nurture a diversified portfolio of quality investment properties, providing accommodation to a wide spectrum of clients and delivering sustainable income distributions and capital appreciation, optimised by effective financial structures. Effectively, net property income received from the property portfolios of South Africa, GOZ and C&R, including interest received, the distributable income received from the equity-accounted and listed investments, less administration and operating overheads, interest on debt and normal taxation, is distributed to Growthpoint shareholders biannually. Growthpoint's distributions are based on sustainable income generated from rentals, trading profits and development fees and distributions and management fees from its Fund Management business, taking into account any ongoing capital and funding requirements

Growthpoint is a public limited liability company incorporated in accordance with the laws of South Africa and under the Companies Act.

As a REIT, Growthpoint is regulated by, and complies with, the JSE listings requirements and rules. A REIT in South Africa receives special tax considerations.

Growthpoint has remained compliant with the Companies Act and is acting in conformity with its Memorandum of Incorporation.

1.2. Description of group businesses

Growthpoint's (together with its consolidated subsidiaries, the **Group**) primary business strategy is to make long-term investments in high quality, rental generating properties in prime metropolitan areas, and to maintain, upgrade or refurbish such properties as necessary to increase their long-term value. As at 31 December 2021, the Group's consolidated property assets were valued at R139.9 billion, its gross lettable area (**GLA**) was 7.4 million square metres and its market capitalisation was R52.7 billion. As at the date of the Information Statement, the Group has six distinct property portfolios:

- **RSA portfolio.** The Group's portfolio in the Republic of South Africa (**RSA**) consisted of 421 properties, excluding the V&A Waterfront (the **RSA portfolio**), as at 31 December 2021. The RSA portfolio was comprised of 43 retail properties (with a GLA of 1.3 million square metres and occupancy rate of 95.3%), 161 office properties (with a GLA of 1.7 million square metres and occupancy rate of 88.8%) and 199 industrial properties (with a GLA of 2.2 million square metres and occupancy rate of 93.5%) as at 31 December 2021. The Group's RSA portfolio also includes the Group's domestic funds management business ("Growthpoint Investment Partners" as further described below). The RSA

portfolio was valued at R70.1 billion as at 31 December 2021 and contributed 56.9% of the Group's net property income in the six ended 31 December 2021.

- **Growthpoint Investment Partners.** As part of the Group's strategic intention to grow new revenue streams, the Group has developed a funds management business, Growthpoint Investment Partners (under which individual funds sit), with asset types and geographies that are different from Growthpoint's existing RSA portfolio. Currently, the Group has two funds focussed on the South African market: GPHH and GSAH.
 - Growthpoint Healthcare Property Holdings (RF) Limited ("GPHH"). The Group holds a 55.9% shareholding in GPHH. As at 31 December 2021, GPHH holds seven healthcare assets consisting of six hospitals and one medical chambers with a GLA of 0.1 million square metres and a value of R3.4 billion. GPHH contributed 3.0% of the Group's net property income in the six months ended 31 December 2021. Growthpoint has control over GPHH and, as such, GPHH is consolidated in the Group accounts.
 - Growthpoint Student Accommodation Holdings (RF) Limited. The Group holds a 16.78% shareholding in GSAH. As at 31 December 2021, GSAH holds seven purpose built student residential properties with 4,979 beds with a GLA of 0.03 million square metres and a value of R2.0 billion. GSAH contributed 0.4% of the Group's net property income in the six months ended 31 December 2021. Growthpoint has control over GSAH and, as such, GSAH is consolidated in the Group accounts
 - Lango Real Estate (Lango). As part of the Group's fund management business, the Group also holds a 16.3% shareholding in Lango. As at 31 December 2021, Lango owns 11 prime office and retail assets located in Ghana, Nigeria, Zambia and land in Angola with a GLA of 145,686 square metres and a value of U.S.\$601 million. Lango is an unlisted investment and is carried at fair value
- **The V&A Waterfront.** The Group holds a 50% interest as part of a joint venture in V&A Waterfront Holdings (Pty) Ltd which holds properties in the V&A Waterfront. The V&A Waterfront is a single 123 hectare mixed-use property which includes retail, office, industrial (primarily fishing), hotel and residential properties. The V&A Waterfront is a major international tourist attraction and one of the most recognised and visited properties in Africa. With strong future development potential, the V&A Waterfront has a total GLA of 0.46 million square metres and Growthpoint's share in its properties were valued at R17.8 billion as at 31 December 2021 (of which Growthpoint's 50% share of the V&A Waterfront represents GLA of 0.23 million square metres and a value of R8.9 billion). Growthpoint's 50% holding in the V&A Waterfront contributed 5.7% of the Group's net property income in the six months ended 31 December 2021. The V&A Waterfront is a joint venture and is equity accounted with the Group recognising its share of the assets and liabilities, income and expenses.
- **Growthpoint Australia.** The Group holds a 62.2% shareholding in ASX-listed Growthpoint Australia. As of 16 March 2022, Growthpoint Australia had a market capitalisation of AUD3.4 billion (R36.6 billion). As at 31 December 2021, Growthpoint Australia holds 57 office and industrial properties in Australia with a GLA of 1.1 million square metres and a value of R58.5 billion. Growthpoint Australia contributed 24.2% of the Group's net property income in the six months ended 31 December 2021. Growthpoint has control over Growthpoint Australia and, as such, Growthpoint Australia is consolidated in the Group accounts.
- **C&R.** The Group holds a 60.8% shareholding in LSE-listed C&R. As at 31 December 2021, C&R holds seven community shopping centres in the United Kingdom with a GLA of 0.3 million square metres and a value of R11.3 billion. C&R contributed 6.3% of the

Group's net property income in the six months ended 31 December 2021 Growthpoint has control over C&R and, as such, C&R is consolidated in the Group accounts.

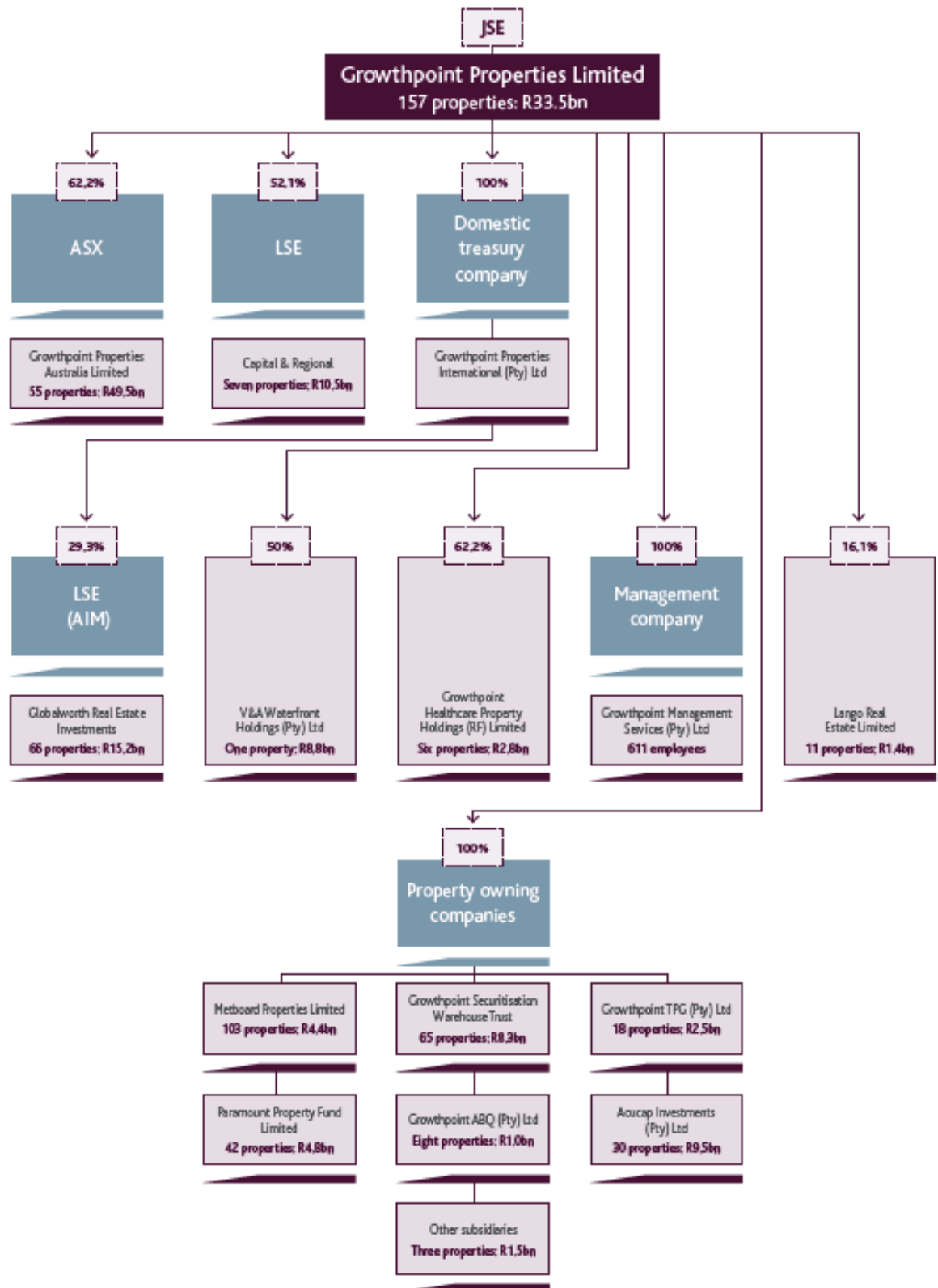
- **Globalworth.** The Group holds a 29.4% interest in the London Stock Exchange AIM-listed Globalworth. Globalworth is a leading real estate company, focussed on predominantly high quality office properties in Poland and Romania. As at 31 December 2021, Globalworth holds 66 properties in Romania and Poland as at 31 December 2021. Globalworth has a total GLA of 1.3 million square metres and a portfolio open market value of €3.1 billion as at 31 December 2021. Growthpoint's 29.4% share of the property value was valued at R16.5 billion as at 31 December 2021. Growthpoint's interest in Globalworth contributed 6.9% of the Group's net property income in the six months ended 31 December 2021. Globalworth is an associate of the Group and equity accounted, with the Group recognising its share of the assets and liabilities, income and expenses.

Growthpoint internally manages its RSA portfolio, including GPH, and employs 613 people across three regional offices and various individual properties in South Africa as at 31 December 2021. Growthpoint performs the asset management function for GSAH and Feenstra Group performs the property management function.

The V&A Waterfront, Growthpoint Australia, Globalworth, C&R and Lango are independently managed and each have their own respective management team, board of directors and board committees. GPH and GSAH each have their own board of directors and board committees.

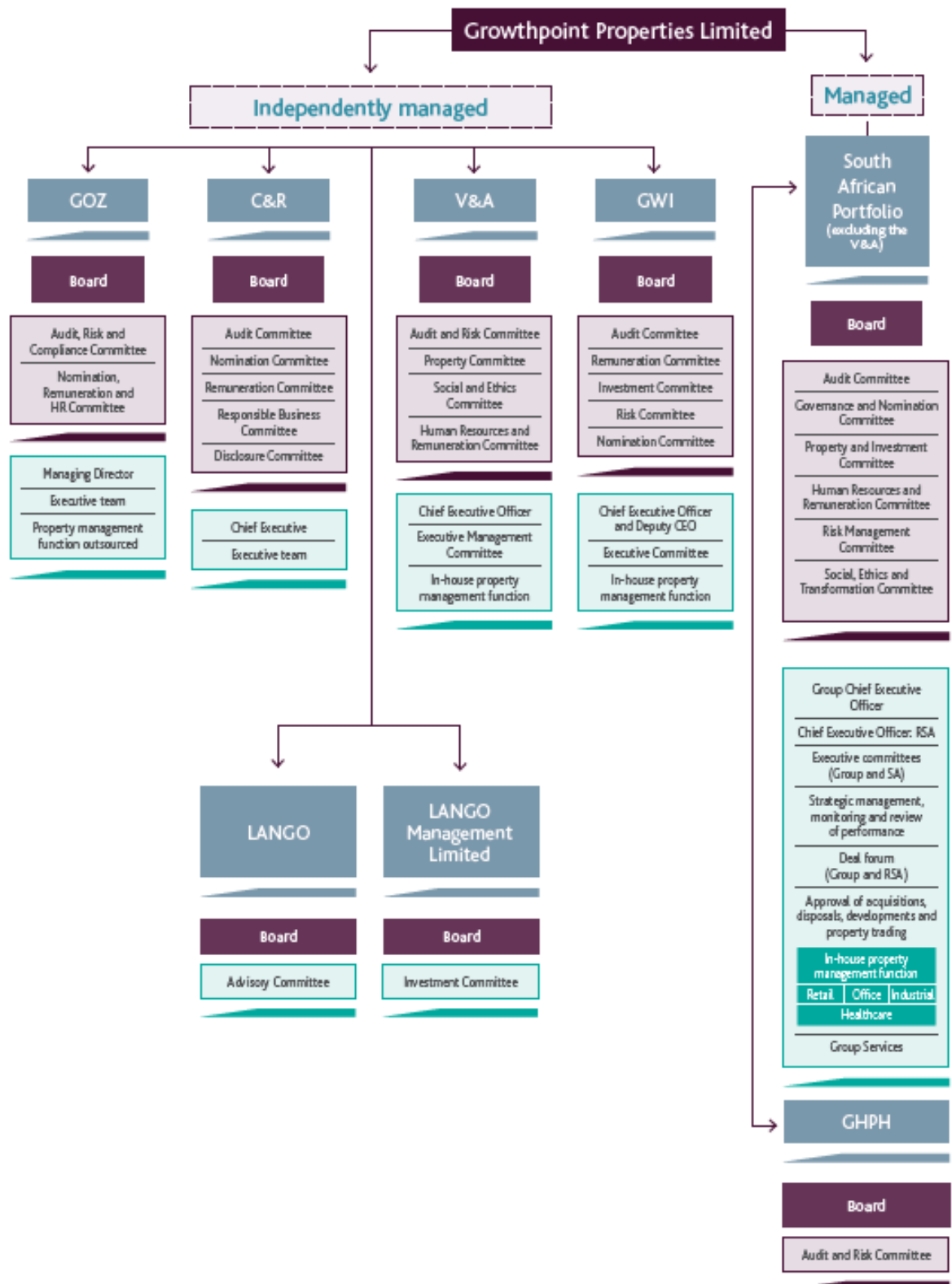

1.6. King IV and Ethics Application and Compliance

The Board of Directors of the Group are bound by a code of ethics that forms part of the Board Charter. The code aims to ensure that they conduct Growthpoint's business in line with the highest ethical standards. In particular, it seeks to ensure compliance with relevant legislation and regulation, in a manner that is beyond reproach. Growthpoint's code of ethics is as follows: The Board of Directors of Growthpoint commits itself to ensure, as far as it lies within its powers to do so, that Growthpoint and its agents conduct the business according to the highest ethical standards and, in particular:

- Comply with all laws of the country that affect Growthpoint;
- Comply with the rules of the JSE Limited;
- Not act in any way that may be regarded as harmful business practice;
- Act in the best interests at all times of the various stakeholders;
- Be transparent in disclosing all material information that may influence investors and potential investors;

- Growthpoint's mission and values;
- Employee integrity, to encourage employee compliance with policies and standards of best practice;
- Anti-corruption and gift declaration policy;
- Whistle-blowing and protected disclosures, to encourage employees to raise concerns about workplace malpractice without fear of victimisation or reprisal;
- Substance abuse and sexual harassment, forbidding these practices in the organisation.
