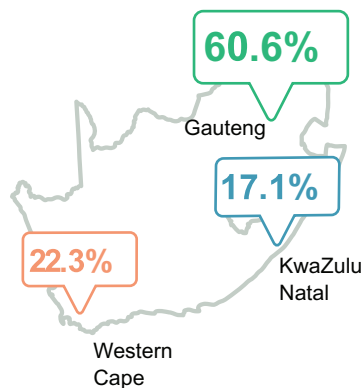
Our primary focus is streamlining and optimising our Industrial portfolio and prioritising the needs of our clients.

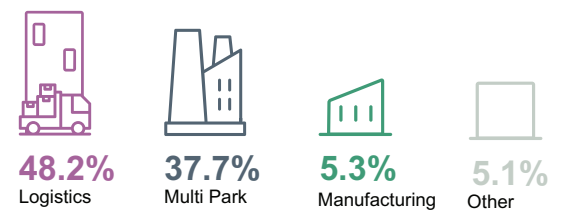
